# Objectives and investment policy

- The aim is to provide capital growth of your investment over time.
- The fund will invest primarily in equity securities (shares) or similar securities of companies based in any country of the European Monetary Union.
- The fund may invest in companies of any size, but, will invest mainly larger sized companies.
- The fund may invest up to 10% of its assets in other open-ended funds, including other funds of HSBC.
- The fund may use derivatives to meet its investment objectives.
- The fund may also use derivatives for hedging or efficient portfolio management purposes (such as to manage risks or costs or to generate additional capital or income).
- The fund is actively managed and does not track a benchmark. Consideration may be given to a reference benchmark when selecting investments. The reference benchmark for the fund is MSCI EMU Net.
- You may sell your investment on any working day by submitting an application to the Administrator before the dealing deadline.
- Income is rolled up into the value of your investment.
- Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

### More about this rating

# Risks materially relevant not adequately captured by the SRRI

- **Exchange rate risk** Investing in assets denominated in a currency other than that of the investor's own currency perspective exposes the value of the investment to exchange rate fluctuations.
- **Derivative risk** The value of derivative contracts is dependent upon the performance of an underlying asset. A small movement in the value of the underlying can cause a large movement in the value of the derivative. Unlike exchange traded derivatives, over-the-counter (OTC) derivatives have credit risk associated with the counterparty or institution facilitating the trade.
- Operational risk The main risks are related to systems and process failures. Investment processes are overseen by independent risk functions which are subject to independent audit and supervised by regulators.


