Objectives and investment policy

- ▶ The aim is to provide capital growth and income on your investment over time.
- ▶ The fund will normally invest at least 90% of its assets in bonds, the value of which is linked to inflation.
- ▶ The fund invests in high quality bonds issued by companies, governments or government related entities of developed markets and emerging markets. Up to 15% of the fund's assets may be invested in emerging markets.
- ▶ The fund may invest in bonds denominated in developed market or emerging market currencies. The fund's primary currency exposure will be to US Dollars (USD).
- ▶ The fund will normally hedge non-USD exposures into USD. At times, however, the fund may have exposure to non-USD currencies, including emerging market currencies. Normally the fund's exposure to non-USD currencies will be limited to 10% of its assets.
- ▶ The fund may invest up to 10% of its assets in funds (including other funds of HSBC Global Investments Funds).
- ▶ The fund may use derivatives to meet its investment objectives.
- ▶ The fund may also use derivatives for hedging or efficient portfolio management purposes (such as to manage risks or costs or to generate additional capital or income).
- ▶ The fund is actively managed and does not track a benchmark. Consideration may be given to a reference benchmark when selecting investments. The reference benchmark for the fund is BofA Merrill Lynch Global Government Inflation Linked Bond MLCU Q977 Hedged USD.
- ▶ The reference currency of the fund is USD. The reference currency of this share class is USD.
- ▶ You may sell your investment on any working day by submitting an application to the Administrator before the dealing deadline.
- ▶ Income is rolled up into the value of your investment.
- ▶ Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

More about this rating

The rating is based on price volatility over the last five years, and is an indicator of absolute risk. Historical data may not be a reliable indication for the future. Why is this fund in category 4?

Fixed income securities are more risky than money market instruments given increased credit and interest rate risk. However, debt securities are not exposed to equity risk and are therefore less risky than equity securities.

Risks materially relevant not adequately captured by the SRRI

- ▶ **Interest rate risk** As interest rates rise debt securities will fall in value. The value of debt securities is inversely proportional to interest rate movements.
- ▶ **Credit risk** Issuers of debt securities may fail to meet their regular interest and/or capital repayment obligations. All credit instruments therefore have potential for default. Higher yielding securities are more likely to default.
- ▶ **Exchange rate risk** Investing in assets denominated in a currency other than that of the investor's own currency perspective exposes the value of the investment to exchange rate fluctuations.
- ▶ **Derivative risk (leverage)** The value of derivative contracts depends on the performance of an underlying asset. A small movement in the value of the underlying can cause a large movement in the value of the derivative. Over-the-counter (OTC) derivatives have credit risk associated with the counterparty or institution facilitating the trade. Investing in derivatives involves leverage (sometimes known as gearing). High degrees of leverage can present risks to sub-funds by magnifying the impact of asset price or rate movements.
- ▶ **Emerging market risk** Emerging economies typically exhibit higher levels of investment risk. Markets are not always well regulated or efficient and investments can be affected by reduced liquidity.
- ▶ **Operational risk** The main risks are related to systems and process failures. Investment processes are overseen by independent risk functions which are subject to independent audit and supervised by regulators.

The charges you pay are used to pay the running costs of the fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.

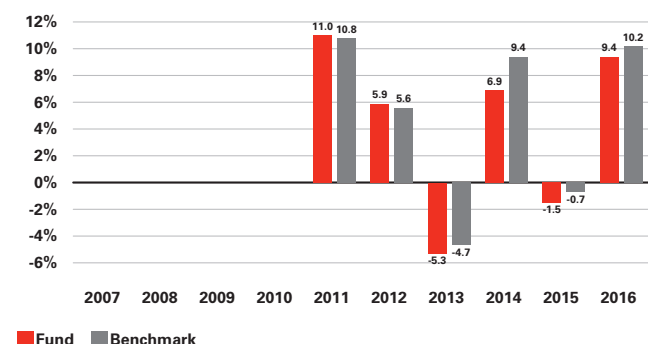
The Entry and Exit charges shown are the maximum that may be charged. In some cases you may pay less. You can obtain the actual charges from your financial adviser.
