Objectives and investment policy

- ▶ The fund aims to track as closely as possible the HSBC Economic Scale Index US (the "Index").
- ▶ The fund invests in equity securities (shares) of companies in the same proportions as their weighting in the Index. This is known as "full physical index replication".
- ▶ In certain circumstances the fund need not hold all of the equity securities of the Index and may hold equity securities which are outside of the Index. The fund may hold equity securities in a smaller number of companies than the Index, with the aim of delivering the same return as the Index. This is known as "partial physical index replication".
- ▶ The Index is made up of equity securities of companies in the United States of America. Companies are represented in the Index in proportion to their economic contribution to the economy of the United States of America. The approach differs from and aims to generate a higher return for a similar level of risk than the more traditional market capitalisation indices.
- ▶ Where the fund's investment in certain equity securities of the Index is restricted, it may use derivatives to meet its objectives.
- ▶ The fund may also use derivatives for hedging purposes.
- ▶ You may sell your investment on any working day by submitting an application to the Administrator before the dealing deadline.
- ▶ Income is rolled up into the value of your investment.
- ▶ Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

More about this rating

Why is this fund in category 5?

Equity prices tend to fluctuate more than other asset classes as investors directly participate in underlying companies and their earnings.

Risks materially relevant not adequately captured by the SRRI

- ▶ **Exchange rate risk** Investing in assets denominated in a currency other than that of the investor's own currency perspective exposes the value of the investment to exchange rate fluctuations.
- ▶ **Derivative risk** The value of derivative contracts is dependent upon the performance of an underlying asset. A small movement in the value of the underlying can cause a large movement in the value of the derivative. Unlike exchange traded derivatives, over-the-counter (OTC) derivatives have credit risk associated with the counterparty or institution facilitating the trade.
- ▶ **Index Tracking risk** The performance of the Fund may not match the performance of the index it tracks because of fees and expenses, market opening times and regulatory constraints.
- ▶ **Operational risk** The main risks are related to systems and process failures. Investment processes are overseen by independent risk functions which are subject to independent audit and supervised by regulators.


The Entry and Exit charges shown are the maximum that may be charged. In some cases you may pay less. You can obtain the actual charges from your financial adviser.
