## What to Bring to your Appointment:

Each applicant will need to provide the following:

#### □ Identification (ID)

#### Please also bring (required for all loans):

- Proof of Income Earnings for each applicant. If Employed, please provide 3 month's bank account statements or previous 3 months pay stubs. This is not required if your salary is direct-deposited to HSBC
- □ If **Self-employed** or business owner, please provide all stamped Payroll Tax returns from the last 2 years **OR** financial statements from the past 2 years.
- □ **Rental Income (if applicable)** please bring: (1) Copy of signed rental agreement, **and** (2) account statements showing any rental income (if not direct deposited with HSBC)
- □ If you carry credit cards with other banks, please bring a copy of your latest credit card statement(s)

## Additional documentation (may be required):

- □ For an **Education Loan**, please provide: a copy of the student's acceptance letter from the school; **OR** a copy of the invoice for tuition; **OR** a copy of the invoice for online or correspondence courses.
- □ For a **New Vehicle** purchase, please provide a copy of the quote from the dealership or seller
- □ For a **Used Vehicle** purchase, please provide the bill of sale agreed with the seller, **OR** evidence of the sale price (i.e. copy of online ad)
